MATCH FEES: \$25.00 2 DAY PACKAGE FEE INCLUDES ALL MATCHES.

LIMITS OF MATCH: 14 SHOOTERS PER RELAY. MAXIMUM 28 SHOOTERS IF TWO RELAYS. IF THERE ARE 14 SHOOTERS OR LESS, WE WILL HAVE ONE RELAY WITH MINIMUM 30 MINUTE BREAK BETWEEN MATCHES.
